Fancy word or critical concept?

### **Example 1**

There are no Islamic terrorists?

Result: The attacks on 9-11-12 could not possibly be related to Islamic terrorism.

#### **Before:**

Alive to sin A slave of sin (6:20) Free in regard to +R (6:20)

#### After:

Dead to sin
Justified from sin (6:7)
Freed (eleutereo) from sin (6:19)
A slave to God and +R (6:19, 21)

Dead to the Law (7:4)
Free from the Law (7:3)
Tie to the law abolished
(7:7)
So that we can live in the newness of the Spirit
(7:7)

νόμος nomos

Law, principle, Mosaic Law, any lawcode, general, natural, or revealed

Rom. 3:20, "for through the Law comes the knowledge of sin."

Rom. 5:20, "And the Law came in that the transgression might increase; but where sin increased, grace abounded all the more,

1 Tim. 1:8, "But we know that the law is good, if one uses it lawfully, realizing the fact that law is not made for a righteous man, but for those who are lawless and rebellious, for the ungodly and sinners, for the unholy and profane, for those who kill their fathers or mothers."

Rom. 6:14, "For sin shall not have dominion over you, for you are not under law but under grace.

Rom. 6:15, "What then? Shall we sin because we are not under law but under grace? Certainly not!"

Rom. 7:1, "Or do you not know, brethren (for I speak to those who know the law), that the law has dominion over a man as long as he lives?"

Rom. 7:2, "For the woman who has a husband is bound by the law to her husband as long as he lives. But if the husband dies, she is released from the law of her husband."

Rom. 7:3, "So then if, while her husband lives, she marries another man, she will be called an adulteress; but if her husband dies, she is free from that law, so that she is no adulteress, though she has married another man [literally, she became another man's]."

Rom. 7:4, "Therefore, my brethren, you also have become dead to the law through the body of Christ, that you may be married to another—to Him who was raised from the dead, that we should bear fruit to God."
